

## “WALLS CARD CASH GIVEAWAY” OFFICIAL CONTEST RULES

Contest Entry Start Date: Oct 6 Contest Entry End Date: Nov 19

### RULES:

In all contests broadcast on WALLS 102, employees of the Radio Group (d/b/a/ Mendota Broadcasting, Inc. and Laco Radio, Inc.); contest sponsors, employees of other radio stations and their immediate family members are ineligible to win.

No purchase is necessary. Prizes must be picked up within 30 days of winning or the prize is forfeited.

The Radio Group, all participating co-sponsor companies and their advertising and promotional agencies are released and shall be held harmless from any action or liability arising from any station contest or prizes awarded in any station contest. Winners shall be required to sign a release form and affidavit of eligibility to claim their prize. Failure to do so will result in forfeiture of prize.

Winners consent to the use of their name, likeness, and all verbal and written communications with the station for publicity purposes.

All prizes are non-transferable and are not redeemable for cash. The Radio Group reserves the Right to substitute a prize of similar value.

Winners are solely responsible for all applicable local, state and federal taxes. Winner will be required to execute a W-9 Form. Winner may be issued a 1099 MISC federal tax form if in one calendar year the prize value of all prizes won in contests from The Radio Group and/or participating co-sponsors exceeds \$600.00.

Contest/Prizes subject to Federal, State, and local regulations and laws and is void where restricted or prohibited by law.

Upon winning a major prize, or those prizes valued at \$500 or more or winning a trip, the household may not win a second trip or prize valued at \$500 or more within a six (6) month period following the first win. Upon winning a minor prize (valued at less than \$500) broadcast on WAL-S-FM, the contestant, and all those who reside at the contestant's address, is not eligible to win a minor prize for a thirty (30) day period.
